1. Organizer

2. Definitions

Application means the submitted application form and audition video link.

Acceptance means written confirmation from the Organizer confirming admission.

Fees means tuition and any add-ons purchased (including Private Coaching).

Minor means a Participant under the age of 18.

Organizer means MariaKo & Co.

Program means the Masha & Daniil – Beyond Form training program.

Program Start Date means August 19th, 2026.

Scholarship means a tuition waiver granted at the Organizer's discretion.

You/Participant means the applicant or admitted participant.

3. Eligibility, Application & Selection

3.1 Eligibility

The Program is intended for dancers aged 16–25 at the Program start date. Proof of age may be requested. Admission may be refused if eligibility is not met.

3.2 Application Requirements

Applicants must submit:

- Completed application form
- Video of a classical variation (studio or stage)
- Payment of the non-refundable Application Fee

Additional information may be requested for administrative or safety purposes.

3.3 Selection & Capacity

Participants are selected based on artistic evaluation of submitted videos. Decisions are final.

Capacity is limited to 30 participants plus up to two scholarships.

A place is confirmed only upon written Acceptance and full payment.

4. Fees & Payment

4.1 Application Fee

€25 per applicant (non-refundable).

4.2 Tuition

€1,000 for the full Program.

4.3 Private Coaching (Optional Add-On)

€300 per session

Participant may request a specific variation/solo.

4.4 Payment Terms

Full payment is required within the deadline stated in the Acceptance email. Failure to pay may result in loss of the reserved place.

4.5 Scholarships

Scholarships may cover tuition in full or in part at the Organizer's discretion.

4.6 Currency & Transaction Fees

All fees are stated in EUR. Bank and card fees are the responsibility of the Participant.

5. Program Content & Scheduling

The daily structure typically includes:

- One technique class (approx. 1.5 hours)
- Two additional sessions (1–2 hours each)
- Talks and lectures as scheduled

Schedules are posted online and onsite.

The Organizer may reasonably adjust faculty, content, timing, or music format if necessary. Such changes do not automatically entitle Participants to refunds.

6. Health & Fitness to Participate

Participants must disclose any relevant medical conditions or injuries.

By attending, Participants confirm they are medically fit for intensive physical training. Medical advice should be sought where necessary.

The Organizer may limit or stop participation where reasonably required for safety.

Where participation is terminated for reasons not caused by serious misconduct, a proportionate refund for unused Program days shall be provided.

7. Private Coaching Rules

Private Coaching is subject to availability.

Sessions are allocated on a first-confirmed basis.

Rescheduling requires at least 24 hours' notice.

Late cancellations and no-shows are non-refundable.

Safeguarding procedures apply for Minors.

8. Conduct & Safeguarding

Participants must:

- Treat others respectfully
- Follow safety and studio rules
- Refrain from harassment, bullying, or discrimination

Faculty may use professional physical correction. Participants may request verbal correction only.

Safeguarding standards apply to all Minors, including supervised 1:1 session.

Serious misconduct may result in removal without refund.

9. Liability, Risk & Insurance

Participation involves inherent physical risk.

Nothing in these Terms limits liability for:

- Death or injury caused by negligence
- Gross negligence or willful misconduct
- Liability that cannot be excluded under Danish law

Subject to the above, the Organizer is not liable for indirect or consequential losses.

Participants are responsible for adequate accidents, health, travel, and liability insurance.

10. Cancellations & Refunds

This Program is a fixed-date leisure and training service and is generally exempt from statutory withdrawal rights under Danish consumer law.

10.1 Participant Cancellation (Non-Medical)

More than 60 days before Program Start Date August 19, 2026: Refund of tuition minus €150 administrative fee.

30–60 days before Program Start Date August 19, 2026: 50% refund of tuition.

Less than 30 days before Program Start Date August 19, 2026: No refund unless the place is resold, in which case a reasonable partial refund based on covering the Organizer's losses may be issued.

10.2 Medical Cancellation

With official medical documentation preventing participation:

- Refund of 50% of tuition
- Application fee and delivered coaching excluded

Documentation must be provided promptly.

10.3 Organizer Cancellation

If the Organizer cancels the Program, all paid tuition and add-ons will be refunded in full. No liability is accepted for third-party costs. No liability for cancellation due to force majeure.

11. Photography, Video & Media

Photos and videos may be taken for internal documentation based on legitimate interests.

Use for marketing or publication requires explicit consent.

Parental consent is required for Minors.

Consent may be withdrawn at any time.

12. Data Protection (GDPR)

Personal data is processed in accordance with the EU General Data Protection Regulation (GDPR) and Danish data protection law.

We process data for:

- Application assessment
- Program administration
- Health and safety management
- Communication and payment

Data is stored securely and shared only with necessary service providers.

Participants have rights to access, correction, deletion, restriction, and to complain to the Danish Data Protection Agency (Datatilsynet).
